## **DAY HUNTING - 2007 SEASON**

**It is our desire that everyone have a safe and enjoyable hunt with Golden Triangle Outfitters.**

Therefore, prior to arrival and ANY participation in any hunting activities, a signed "Release of Liability" must be submitted and the following terms and conditions must be read carefully:

- 1) HUNTING LICENSE: ALL HUNTERS MUST BE PROPERLY LICENSED AND ARE REQUIRED TO OBSERVE AND ABIDE BY THE RULES HEREINAFTER SET FORTH AND ALL OF THE APPLICABLE RULES, REGULATIONS AND LAWS OF THE TEXAS PARKS AND WILDLIFE DEPARTMENT AND THE STATE OF TEXAS.
- 2) GAME LIMIT: EACH HUNTER MUST KNOW AND OBSERVE THE TEXAS PARKS AND WILDLIFE GAME LIMIT RULES.
- 3) LITTERING: NO TRASH/LITTER SHOULD BE LEFT ANYWHERE ON THE HUNTING LEASE PROPERTY. DO NOT LEAVE ANIMAL REMAINS/TRIMMINGS ANYWHERE ON THE HUNTING LEASE PROPERTY OR ANY OTHER PROPERTY HUNTING AND/OR STAYING AT.
- 4) REFUND POLICY: NO REFUNDS SHALL BE MADE DUE TO WEATHER CONDITIONS. NO REFUNDS ON DEPOSITS!

It is understood that Game Hunting is an activity requiring particular skill and that both experienced and occasional hunter(s) take the risks of bodily injury and personal property damage, including vehicles, whether accidental or otherwise, while participating, actively or inactively, in hunting. It is further understood that while on the premises of the Hunting Lease Property and/or at the Lodging site, each hunter, individually, assumes the risk of: (A) any and all bodily injury, including death; and, (B) loss of and/or damage to any personal belonging to or in the possession of control of said hunter while on the premises of the hunting and/or it's facilities. It is hereby understood that this document constitutes a FULL AND COMPLETE RELEASE OF LIABILITY.
